### RoHS

Industrial electric motors are not listed in Categories of electrical and electronic equipment covered by the RoHS Regulations, as defined in the European Union Restriction of Hazardous Substances (RoHS) Directive 002/95/EC.

However we at COMBIMAC BV can confirm that to the best of our knowledge COMBIMAC electric motors comply with EU RoHS Directive 2002/95/EC as well as RoHS "Recast" Directive 2011/65/EU requirements. A number of parts and materials in COMBIMAC electric motors are procured from external suppliers. We rely on the representations of our suppliers regarding the presence of RoHS substances in these parts and materials. Our suppliers are required to comply and document their compliance with RoHS Regulations.

### REACH

COMBIMAC BV are aware of the European REACH regulation (Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18th December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals) and later amendments.

According to article 31 (1) of REACH regulation suppliers of substances, listed in the so called candidate list (Substances of Very High Concern), are obliged to provide its consumers with a Safety Data Sheet. Furthermore Article 33 of the regulation obliges the supplier of the products, which include substances on the candidate list in a concentration > 0,1 % (w/w) to inform their customers accordingly. COMBIMAC BV maintain regular contact with their suppliers to fulfil this obligations under the REACH regulation with regards to COMBIMAC electric motors. Based on information provided by their suppliers COMBIMAC BV hereby declare that the COMBIMAC electric motors, types as mentioned above comply with the requirements of the REACH regulation.

In case the substances mentioned in the most recent list of Substances of Very High Concern (published by the European Chemicals Agency (ECHA), link: [http://echa.europa.eu/web\\_candidate-list-table](http://echa.europa.eu/web_candidate-list-table)) are contained in the above products, the concentration is less than 0.1 % by weight as defined in REACH Article 84.
